# **CPUC Takes Action to Hold PG&E Accountable for Safety Practices**

The California Public Utilities Commission (CPUC) is conducting a fact-finding review regarding a pattern of Pacific Gas and Electric Company (PG&E) missing inspections and other safety incidents to determine whether a recommendation to place PG&E further within the Enhanced Oversight and Enforcement Process is warranted.

The Enhanced Oversight and Enforcement Process was developed as a condition for approving PG&E's plan for exiting bankruptcy in May 2020. In April 2021, the CPUC placed PG&E into the first step of the Enhanced Oversight and Enforcement Process based on the utility's failure to sufficiently prioritize clearing vegetation on its highest-risk power lines as part of its wildfire mitigation work in 2020.

On Aug. 18, 2021, the CPUC's President, Marybel Batjer, notified PG&E that she has directed CPUC staff to conduct a fact-finding review regarding a pattern of PG&E self-reported missed inspections and other self-reported safety incidents to determine whether a recommendation to advance PG&E further within the Enhanced Oversight and Enforcement Process is warranted.



Since learning of the company's failure to prioritize vegetation clearing, PG&E has self-reported missed inspections of hydroelectric substations, distribution poles, and transmission lines. PG&E has also reported missing internal targets for enhanced vegetation management and failing to identify dry rot in distribution poles treated with Cellon coating. Many of these issues have occurred in High Fire Threat District areas. Since receiving these reports, PG&E has partially achieved remedial and corrective actions, and the CPUC and the Office of Energy Infrastruc-

ture Safety have collaborated to actively monitor, assess, and respond as PG&E addresses each of the deficiencies. However, the pattern of deficiencies warrants the fact-finding review that President Batjer directed.

# **CPUC Decreases Cost of Telecommunication Services** for the Incarcerated

n ongoing efforts to ensure affordable telecommunications services for all Californians, the CPUC has acted to decrease the high rates and fees that financially burden incarcerated people, their families, and others that provide them with support, impeding their ability to communicate—a burden that has been made more difficult by the ongoing COVID-19 pandemic.

In an Aug. 19, 2021 decision, the CPUC set a per-minute cap of seven cents (\$0.07) for intrastate debit, prepaid calls, and collect calls for all incarcerated person calling services (IPCS) operating within California. The CPUC also prohibited single-call service fees, automated payment/automated deposit fees, live agent fees, and paper bill fees; limited third-party financial transaction fees to the pass through of the exact third-party fee, with no markup, up to a limit of \$6.95 per transaction; and prohibited the markup of any mandatory pass-through government taxes and fees.

Additionally, the CPUC directed telephone companies to fully disclose the rate caps and ancillary fee requirements

on websites, bills, and marketing materials, and to maintain information on the adopted rate clearly and prominently on their websites.

Commissioner Martha Guzman Aceves, who is assigned to the proceeding, said, "While we will continue to explore more comprehensive, long-term options for relieving the burdens on communication faced by incarcerated people, this decision gives those people and their loved ones some immediate relief during this difficult time."

On August 8, 2020, the Federal Communications Commission (FCC) proposed to update its rate caps on out-of-state calls and urged state partners to take action to address the high in-state inmate calling service rates because the FCC lacked the authority to cap intrastate calling prices. On October 8, 2020, the CPUC opened a proceeding to ensure that incarcerated people and their families have access to affordable communications services. The CPUC has not previously regulated the rates of telephone services provided to people incarcerated in California's jails and prison.

# CPUC and Energy Safety to Hold Public Meeting on SDG&E and SCE Safety Practices

The CPUC and the Office of Energy Safety Infrastructure (Energy Safety), in their joint commitment to safety and transparency, have called on San Diego Gas & Electric (SDG&E) and Southern California Edison (SCE) to present updates on their electric safety related efforts.

The Aug. 25 meeting from 10 a.m. - 12:30 p.m. will provide the CPUC, Energy Safety, and the public thorough information about the electric safety related efforts of SDG&E and SCE, including wildfire prevention actions and potential infrastructure safety issues. Members of the Board of Directors of both utilities will present and answer questions from the CPUC and Energy Safety, and there will be opportunity for public comment.

The virtual meeting can be accessed via webcast (Spanish captions will be

available) and phone (both an English and Spanish line), and the webcast will be archived for subsequent viewing. Those who would like to make comment must make comment by phone.

The CPUC enforces regulations to ensure power plants and utility companies run a safe and reliable electric system. The CPUC's Safety and Enforcement Division (SED) conducts audits and inspections, investigates safety incidents or system problems, issues fines, oversees corrective actions, and advises the CPUC on related matters. The CPUC's Safety Policy Division reviews and oversees risk analysis and mitigation planning by investorowned utilities, conducts comprehensive safety culture assessments, analyzes safety metrics, and develops policies and rules designed to improve safety performance.





Energy Safety assesses electrical corporations' Wildfire Mitigation Plans, annual wildfire-specific safety culture assessments, issues safety certifications to utilities, and evaluates executive compensation structures. Energy Safety maintains compliance through field inspections, audits, and review of utility compliance and Independent Evaluator reports.

Separately, the CPUC set the selection process, scope of work, and schedule for an Independent Safety Monitor that will augment CPUC oversight of PG&E.

As a condition of approving PG&E's plan for exiting bankruptcy in May 2020, the CPUC ordered an Independent Safety Monitor that will be functionally equivalent to the Federal Monitor that was appointed as part of PG&E's probation in criminal court. The Independent Safety Monitor will augment the CPUC's oversight of PG&E's execution of real-time operations to ensure that the utility is focused on long-term outcomes that promote safety and reliability. A Request for Proposals (RFP) will be issued seeking an Independent Safety Monitor for five years at a cost not to exceed \$5 million per year to be paid by PG&E's shareholders. The CPUC will review and select the Independent Safety Monitor from eligible candidates that respond to the RFP.

The CPUC's oversight of PG&E includes broad investigation and enforcement authority, examination of rates and costs, pressing for progress on the utility's efforts to reduce the risk of wildfire ignited by its equipment, ensuring safe execution of Public Safety Power Shutoffs, regulating the safety of the utility's natural gas system, and ensuring PG&E is progressing toward modernizing its electric grid. The Independent Safety Monitor will augment these oversight efforts.
