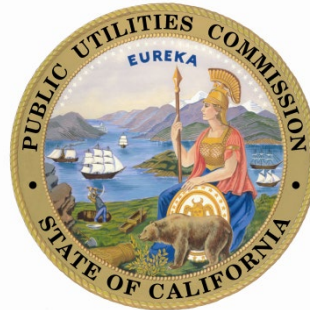

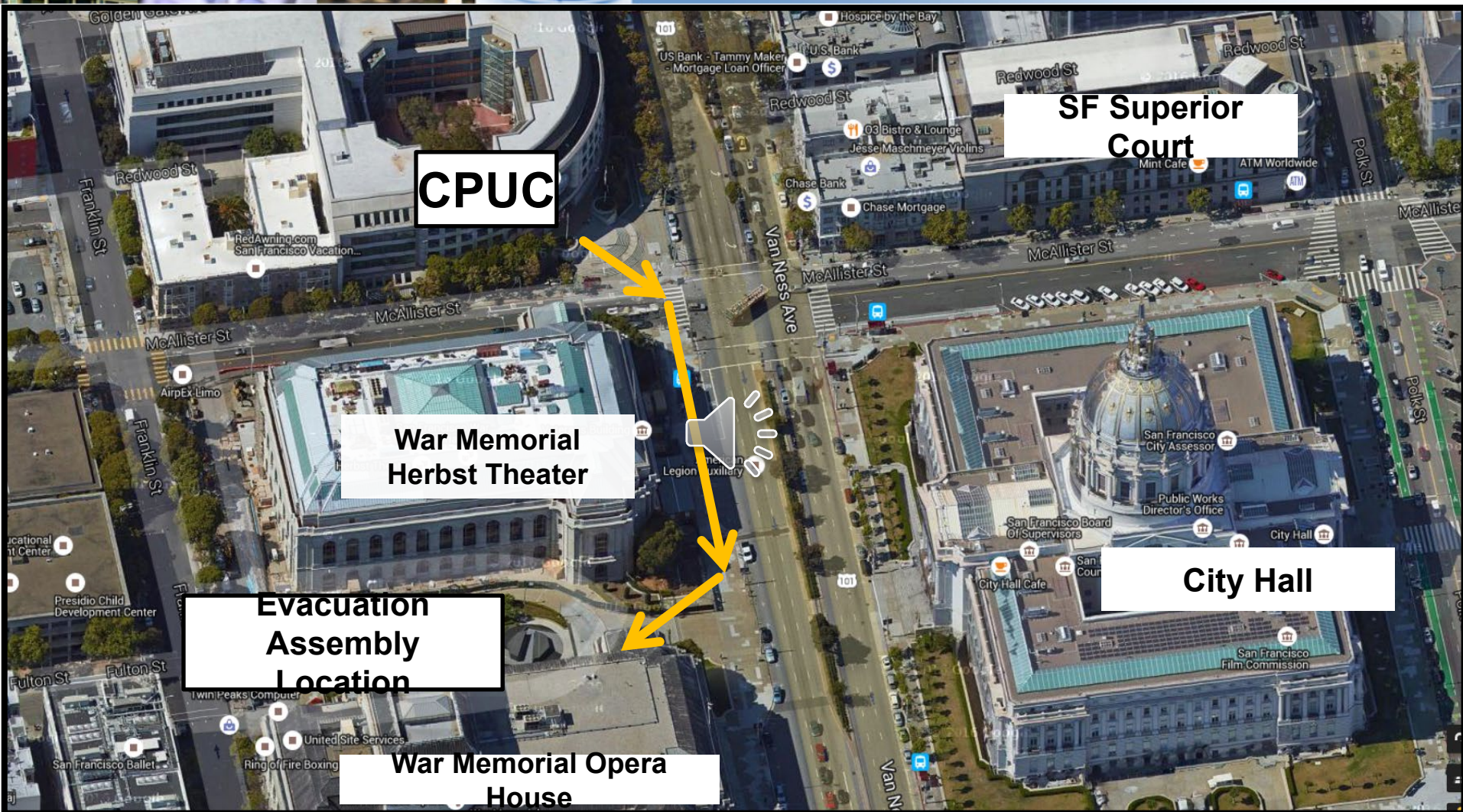
Emergency Evacuation

Commissioner Code of Conduct

Item #28 [17738] – Decision Requiring Electric System Reliability Procurement for 2021-2023

R.16-02-007

Order Instituting Rulemaking to Develop an Electricity Integrated Resource Planning Framework and to Coordinate and Refine Long-Term Procurement Planning Requirements.

Ratesetting

Comr Randolph - Judge Fitch

PROPOSED OUTCOME:

- To ensure electric system reliability beginning in 2021, this decision:
- Recommends that the State Water Resources Control Board consider extensions of once-thru-cooling compliance deadlines currently set for December 31, 2020 of up to three years, for Alamitos and Huntington Beach units, two years for Redondo Beach units, and one year for Ormond Beach units.
- Requires all load-serving entities (LSEs) serving customers within the California Independent System Operator area to procure an additional 4,000 megawatts (MW) of incremental electric resources that qualify as system resource adequacy and serve renewable integration purposes, with at least 60 percent coming online by Summer 2021, 80 percent by Summer 2022, and 100 percent by Summer 2023.
- Requires investor-owned utilities to conduct an all-source solicitation for their portion of the 4,000 MW, and file Tier 3 advice letter(s) with the proposed contracts, by January 1, 2021 or sooner, if possible.
- Requires additional reporting and tracking of electricity resource contract status semi-annually by all LSEs.

SAFETY CONSIDERATIONS:

- Procurement actions as a result of this decision are intended to ensure safe and reliable electric service beginning in 2021, when electricity shortages would otherwise be possible.

ESTIMATED COST:

- Unknown until procurement activities are concluded.

2019 Legislative Overview

❖ **122 bills tracked:**

- 85 (70%) failed passage
- 37 (30%) sent to the Governor's Desk

❖ **Took ONE formal legislative position**

❖ **Participated in NINE legislative committee oversight hearings**

❖ **Provided FIVE formal legislative staff briefings**





2019 Legislative Engagement & Cross Agency Collaboration

- ❖ Engaged with the Senate and Assembly policy and fiscal committee consultants.
- ❖ Actively coordinated with the Department of Finance on bill fiscal analyses.
- ❖ Collaborated with the California Energy Commission, California Independent System Operator, California Air Resources Board, California Office of Emergency Services, California Department of Forestry and Fire Protection, and the Department of Conservation - Division of Oil, Gas and Geothermal Resources.
- ❖ Updated the Governor's Office on key policy issues.





CPUC Formal Legislative Positions

- **AB 1366 (Gonzalez): Voice over Internet Protocol and Internet Protocol enabled communications services.**
 - **CPUC Position:** **OPPOSE**
 - **Status:** *Held in committee pursuant to Senate Rule 29.10, September 11, 2019*

This bill proposes to extend, for an additional ten years, the qualified prohibition on any state or local entity regulating Voice over Internet Protocol (VoIP) and Internet Protocol (IP) enabled services. The bill includes an additional qualification restricting the CPUC from taking regulatory action, unless expressly and specifically directed by the Legislature, in the interest of public safety or consumer protection, among other provisions.

The Commission took an oppose position due to concerns with restricting state oversight given the increase in catastrophic disasters and deenergization events in California. All essential infrastructure and services in California must receive heightened scrutiny for its reliability, service quality and impact on public safety. Communications infrastructure, just as electric infrastructure, has demonstrated service quality deficiencies, as well as disaster response and reliability issues, that require proper oversight and review.





Communications Bills Summary

Communications bills signed this year focused on:

- Strengthening the state's communications grid by refining rules for the distribution of emergency alerts and improving carrier coordination with public safety officials.
- Providing consumers with protections against fraudulent calls.
- Extending the sunset of the Deaf and Disabled Telecommunications Program and making program enrollment easier.
- Expanding representation on the California Broadband Council.





Energy Bill Summary

Energy bills signed this year focused on:

- Improving electric and gas infrastructure safety
- Integrating electric vehicles into the electric system
- Deploying customer energy resources
- Enabling responsible electric retail procurement choice
- Clarifying existing energy resource planning processes
- Incentivizing biomethane production
- Expanding electric and gas utility oversight





Safety Bills Summary

Safety bills signed this year focused on:

- Strengthening California's ability to prevent and recover from catastrophic wildfires
- Boosting the state's forest management activities
- Updating requirements for the maintenance and operation of utility infrastructure to reflect changing climate conditions
- Protecting utility workers.





Transportation Bill Summary

Transportation bills signed this year focused on:

- Strengthening existing consumer protection laws for TNC drivers.
- Improving collaboration between the CPUC and local governments on work related to railroad crossings.





Other Bill Summary

Other bills signed this year focused on:

- Expanding the supplier diversity program to third-party power procurement providers.
- Improving CPUC audit and review requirements of regulated entities.

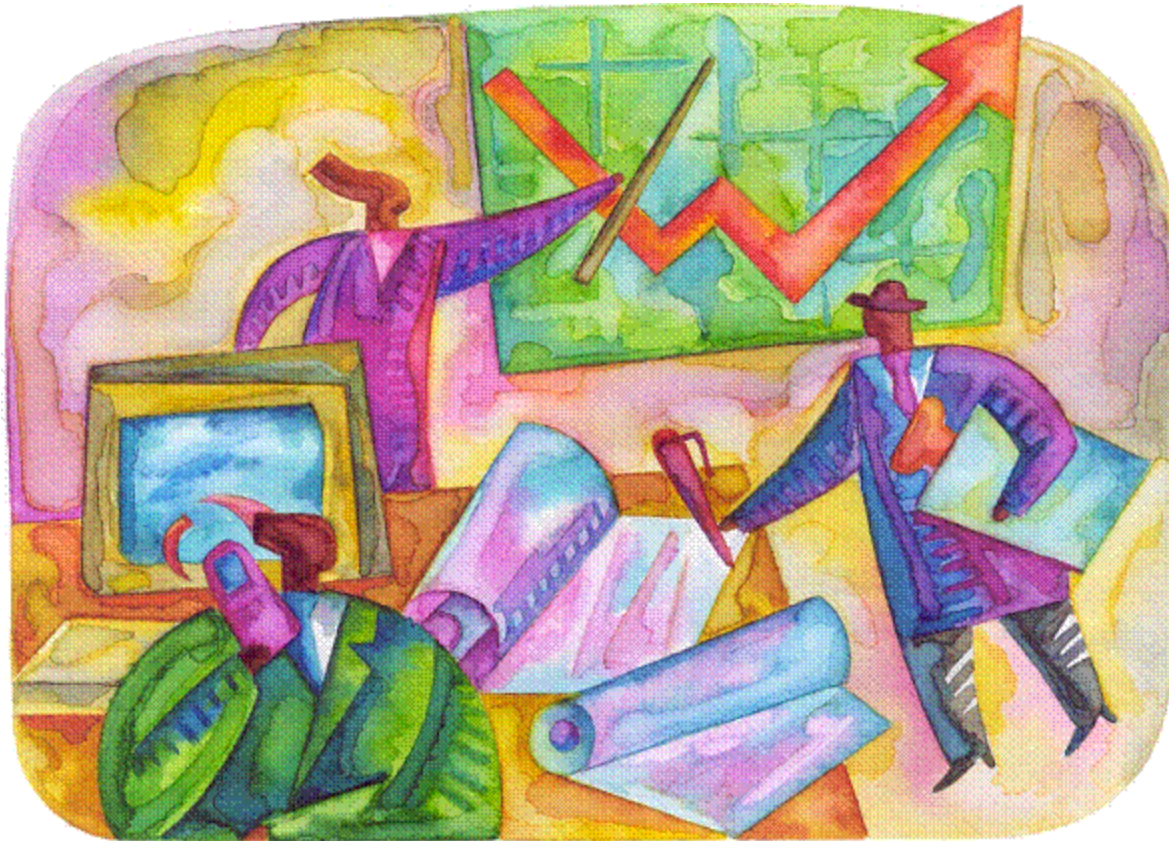

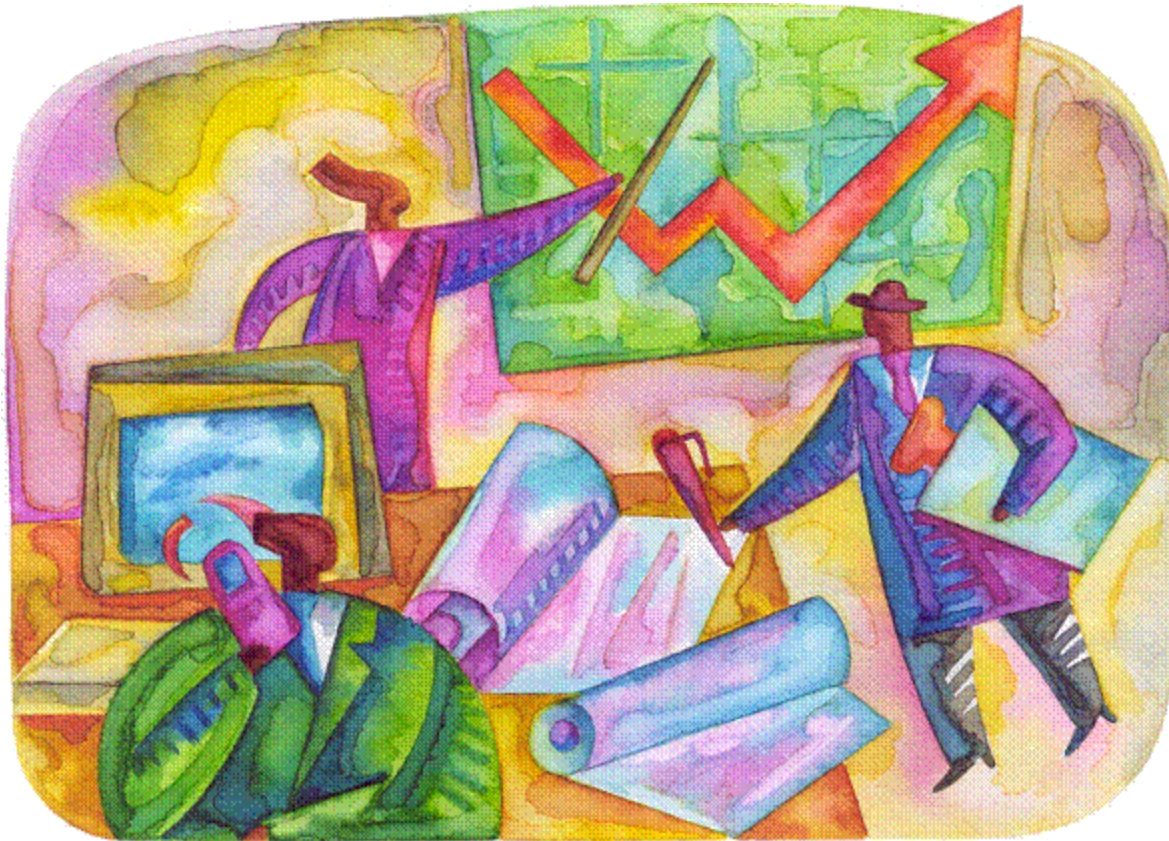
