• Closes this proceeding without addressing the Phase Two Issues, which consider whether to disallow the utilities from collecting revenues they did not collect during the Public Safety Power Shutoff events that occur during the compliance review period.

Item #40 [22469] – Assembly Bill 205 Requirements for Electric Utilities

R.22-07-005

Order Instituting Rulemaking to Advance Demand Flexibility Through Electric Rates.

Ratesetting

Comr. Alice Reynolds - Judge Wang

PROPOSED OUTCOME:

- Implements the requirements of Assembly Bill (AB) 205, Stats. 2022, Ch. 61 to (a) authorize all investor-owned electric utilities to change the structure of residential customer bills by shifting the recovery of a portion of fixed costs from volumetric rates to an income-graduated fixed charge without changing the total costs that utilities may recover from customers, and (b) adjust the large electric utilities' methodology for calculating the average effective discount for California Alternate Rates for Energy.
- Directs Pacific Gas and Electric Company, Southern California Edison Company, and San Diego Gas & Electric Company to begin to implement income-graduated fixed charges in the fourth quarter of 2025 and the first quarter of 2026.
- Adopts a settlement agreement regarding income-graduated fixed charges between Bear Valley Electric Service, Inc., Liberty
 Utilities, PacificCorp d/b/a Pacific Power, and the Public Advocates Office at the California Public Utilities Commission, with
 exceptions to ensure compliance with statutory requirements.

SAFETY CONSIDERATIONS:

- This decision would ensure compliance with statutory requirements to provide bill savings to a low-income customer with average electricity usage in each baseline territory without making any changes to usage. Lower bills for low-income customers will reduce the potential for disconnections of service that jeopardize safety.
- This decision would result in a new residential billing structure that would encourage customers to adopt electric vehicles and electric appliances. California seeks to electrify homes and transportation to reduce greenhouse gas emissions and associated climate impacts that jeopardize safety.

ESTIMATED COST:

• This decision would approve a total of \$35.6 million in implementation costs for the large utilities.

- Adopts Volume One of the Initial Proposal (Volume One) for the Broadband Equity, Access, and Deployment Program.
- Adopts process, whereby a unit of local government, nonprofit organization, or broadband service provider can challenge a determination regarding whether a particular location or community anchor institution is eligible for grant funds, including whether a particular location is unserved or underserved.

Conserving Watershed Lands and Investing in Our Youth The Pacific Forest and Watershed Lands Stewardship Council (Stewardship Council) is a private, nonprofit foundation established in 2004 as part of a 2003 Settlement Agreement and Stipulation with Pacific Gas and Electric Company (PG&E) and the California Public Utilities Commission (CPUC), Decision 03-12-035.



Stewardship Council Mission

- To protect and enhance 140,000 acres of PG&E's watershed lands and uses
- To invest in efforts to improve the lives of young Californians through connections with the outdoors





PG&E's Land Conservation Commitment

As part of a 2003 Settlement Agreement, PG&E agreed to permanently protect approximately 140,000 acres of its watershed lands located primarily in the Sierra Nevada and Cascade mountain ranges and conserve these lands for a broad range of public benefits.





PG&E Watershed Lands


- 140,000 acres of land



Land Program Accomplishments

- Adopted 96 Land Conservation and Conveyance Plans (LCCPs)
- 96 land transactions-40 land donations, placement of conservation easements on 86 properties and 10 conservation covenants on 10 land donations to USFS, protecting approximately 140,000 acres in perpetuity





Status of Environmental Enhancement Program

Approximately \$15.4 million awarded or budgeted for projects ranging from habitat restoration to cultural resource protection, to recreational improvements

Remaining funds will primarily be used to fund additional enhancement projects via Sierra Nevada Conservancy



The Settlement directed PG&E to provide \$30 million in ratepayer funding to provide a wilderness experience for urban youth, especially disadvantaged urban youth, and to acquire and maintain urban parks and recreation areas.

In 2013, Stewardship Council executed a Major Grant Agreement with Justice Outside for \$10.76 million to oversee and award grants to youthserving entities in PG&E territory and to establish a permanent youth-focused program.



Purpose of the Major Grant Agreement to Justice Outside:

"To provide greater resources to connect children, youth, and young adults in the PG&E service territory to nature, parks, open spaces, and the outdoors, and will particularly serve the needs of underserved youth. A portion of the Grant Funds may be used to provide seed money that would establish a permanent program for young people who are least likely to enjoy the wonder of California's natural beauty."



- Since 2013, Justice Outside has awarded 300 grants for more than \$7 million.
- As of 1/1/23, Justice Outside has completed its work funded through our Major Grant Agreement.
- End of the program report included as part of the Stewardship Council's final report.
- Justice Outside continues to support youth programs throughout California and across the country.



Youth Investment and Land Program

As part of our environmental enhancement program, Stewardship Council also allocated over \$5 million to San Joaquin County Office of Education at the Sky Mountain Camp to purchase and update a science camp for Central Valley youth.

Stewardship Council Dissolution

- Stewardship Council has officially dissolved
- A small group of board officers will stay to make any remaining decisions through 2024
- Sierra Nevada Conservancy will award additional grants to grantees on Watershed Lands and oversee the environmental enhancement program through 2025.
