#### A. Mobile Home Park Utility Program Overview

#### 1. Executive Summary

On March 14, 2014, the California Public Utilities Commission (CPUC or Commission) issued their final Decision (D.) 14-03-021 to approve a three-year "living pilot" (pilot) program focusing on converting 10% of Mobile Home Park (MHP) spaces in California from master-meter service to direct utility service.

The primary purpose of the pilot program is to replace MHP operated utility systems with direct public utility gas and electric service for MHP residents. Eight utilities, including Pacific Gas and Electric Company (PG&E), were required to participate beginning January 1, 2015 to implement the CPUC Decision.

#### 2. CPUC Decision's Pilot Program

- Three-year pilot program starting January 2015.
- Construction targeted to complete by December 2017; however, utilities are allowed to complete the three-year pilot program in 2018 provided construction already began in 2017.
- Approximately 10,500 permitted spaces to convert in 150 MHPs in PG&E's service territory.
- Initial applications received must be prioritized by the CPUC and the Department of Housing and Community Development (HCD). The CPUC shall release a list that will be further assessed and parsed by PG&E and released to contractors.
- PG&E must provide outreach to customers and other utilities, and share trenches where possible.

#### 3. Program Vision

Working with the CPUC Safety and Enforcement Division and the HCD, PG&E will address the highest risk MHPs, and in doing so PG&E will also provide enhanced service and reliability for the residents.

#### 4. Report Objectives

This report complies with the directives stated in D.14-03-021. As specified in Section 4.3.4 of D.14-03-021, this first status report, due by February 1, 2016, includes:

- Number of initial applications received (Figure 1).

- Timeline for implementation of the three-year pilot program (Figure 2).
- Problems experienced with the prioritization process and potential future solutions (Table 1).
- Information about each MHP selected for conversion, including the general location (city and county), the number of spaces, what utility services will be converted and whether the conversion involves another Commissionregulated utility or other municipal or public agency provider (Table 2).

#### **B.** Program Status

As shown in Figure 1 below, PG&E received 641 initial applications (Forms of Intent (FOI)). As shown in Figure 2, PG&E has completed Detailed Application Signing.
